

Under the Denmark Green Card scheme, Non-European Union skilled migrants are allowed to enter Denmark under a renewable 3 year permit for the purpose of finding a job. The Denmark Green Card Scheme is different from the US Green Card, which grants permanent residence. Under this scheme you can live and work in Denmark.

Denmark provides excellent opportunities to skilled professionals. Several Danish companies are facing severe shortage of skilled manpower and are looking overseas to find skilled talent. Denmark Green Card is a new way of allowing overseas qualified individuals to visit Denmark and find job in Denmark.

Skilled individuals with special qualifications can obtain employment in areas where there is acute shortage of Danish work force. Skilled overseas individuals can easily obtain resident and work permit in Denmark. The Denmark Green Card Scheme has been expanded this year to allow qualified skilled Indian professionals to apply.

Denmark Green Card Features

- Allows you to travel to Denmark and work up to three years
- This visa can be extended for another 4 years. The extension is on the basis of being able to support yourself without recourse to public funds and depending on the work experience gained
- After 5 years, you can apply for a Permanent Residency
- You will be eligible to apply for a Danish Nationality or Citizenship status, if you have lived in Denmark for a continuous period of at least 9 years
- Shorter Process time, be in Denmark in less than 12 Months
- Allows you to take your immediate family members and they too can work/study in Denmark

Requirements

- Need to prove necessary qualifications
- Bonus points if you have a valid job offer from a Denmark employer
